Dr. Ross next called attention to a formatting error in recent rule amendments and to an inadvertent deletion of a provision in 4732-17-01 (C) that prohibits psychologists providing treatment to children from making parenting time or custody recommendations. Following discussion, it was agreed by consensus that the rule at issue would be revisited for possible amendment.

The ASPPB Annual Meeting Summary (October 2019) distributed by ASPPB was reviewed.
