PRESIDENT'S REPORT

Dr. Randolph called attention to the likely need for an additional date for oral examinations prior to October 12, 2017, based on Dr. Ross' recommendation. Mrs. Borges and Dr. Drude indicated that they will block out the morning of September 22, 2017, if overflow candidates need to be scheduled.

Dr. Randolph distributed a document with various options and issues highlighted relative to the process of examining psychologist and school psychologist license candidates. Discussion followed about the purpose of the oral exam, the importance of ensuring that candidates have a minimum knowledge base about the laws and rules, and about limitations relative to ensuring that the knowledge can be applied in practice. Following discussion there was consensus to maintain the current examination process and structure.

Next, the strategic plan was reviewed, and a proposed goal relative to studying the oral examination process was struck.
