Dr. Ross presented and reviewed the following reports: Budget Report—Expenditure and Revenue Detail FY20 Q1; Budget Report—Payroll Detail FY20 Q1; Enforcement Report FY20 Q1; and, Licensing/Certification Detail FY20 Q1.

Dr. Ross then presented a draft report completed upon request from the Governor's Working Group on Med Board/Richard Strauss. By consensus the Board agreed that the document was appropriate. He updated the Board on recent rule filing activity, investigation progress, and Board vacancies. Dr. Ross then announced that he and Dr. Rabold have discussed an interest in updating the COBA record retention rule to seven (7) years after the last date of service so it comports with the BACB requirements and the Ohio Psychology Rules. The Board indicated consensus with this idea, and Dr. Ross agreed to revisit in 2020.

RULE AMENDMENT FOLLOW-UP

Following up on a discussion from the July meeting, the Board discussed the possibility of studying issues surrounding guardianship and impaired adults as related to informed consent and other issues. It was agreed that the issue, first raised during the rule filing process in July 2019, needs additional definition. There was consensus that the Board retreat in 2020 would be an appropriate venue for additional discussion, and Dr. Randolph stated that invitations could be extended to representatives from adult protective services and probate courts.

Dr. Ross thanked Dr. Fields for his work eliminating awkward pronouns (e.g., “he or she”) in a marked-up draft of the rules of professional conduct. Given that the board’s five-year review of all rules is just ending, it was agreed by consensus of the Board to delay any filing specific to the pronouns until the next significant rule filing.

LEGISLATION UPDATES

Dr. Ross called attention to legislation/bill summaries he had distributed with the agenda: SB166/HB290 Prohibit unlawful sexual contact between healthcare professionals and patients; HB323 Psychologists-prescribing; and, HB263 Disqualifying criminal offenses “The Fresh Start Act of 2019.”

Specific to HB23, Dr. Randolph voiced concerns about the “collaborative relationship” with a physician, and the appearance that it is supervisory in nature vs. purely collaborative. Following additional discussion, the Board agreed to remain neutral on the bill with interested party testimony to be offered as warranted to express readiness to promulgate rules in response to any statutory changes. Dr. Ross noted that he will investigate a need for an appropriation to fund changes to add a new license type or endorsement to the eLicense Ohio system.

REQUEST FOR BOARD REVIEW OF EMPLOYMENT SITUATION

Finally, Dr. Ross called attention to a letter from two psychologists distributed with the agenda concerning a labor situation at Twin Valley Behavioral Health in Columbus. After discussion, there was consensus that the issue is consistent with a labor dispute, it does not relate to the Board’s mission, and the Board directed Dr. Ross to convey this to the authors of the letter.
